The Colorado Mammography Society has been given the task by the membership to provide a scholarship fund for those interested working in the mammography profession. The scholarship fund will be named in memoriam of Susanne Amitrano, R.T.R., M.

Susanne was an active member for many years in the Colorado Society of Radiologic Technologists and also the Colorado Mammography Society. Susanne known to us as Sue, was very involved in the early years of the Mammography Society. Sue would invite the board and officers over to her father's home where they would fold, stamp, and mail out fliers for the CMS meetings. For those of us who knew Sue, know the true love, respect and passion she had for the mammography profession.

The goal of the scholarship is to provide assistance to those individuals interested in pursuing a mammography certification. The State of Colorado requires those individuals performing mammography procedures to be ARRT Mammography Certified. To offset the cost of the continued education required to sit for the ARRT Mammography Registry, the Colorado Mammography Society is offering a \$500.00 scholarship for those interested in pursuing their education in this modality.

The board and officers of the Colorado Mammography Society has appointed a committee to review all scholarship applications and to choose a recipient. The committee appointed by the CMS board and officers will be three members with one being a present board member, one educator, and one member of the CMS.

The recipient will be presented with the Memorial Scholarship at the May 2019 Spring Conference. In addition to the scholarship, the recipient will be given a one year membership to the Colorado Mammography Society.
